A New Drink Jointly Developed with Hot Yoga Studio LAVA "NightVeilTM" Now on Sale -The First Food with Function Claims Containing an Active Form of Coenzyme Q10 for "Skin" and "Sleep"-

(Headquarters: Minato-ku, Tokyo; President: Takahiko Sumi). "NightVeilTM" will be sold through Kaneka's affiliate company, Kaneka Foods Corporation (Headquarters: Shinjuku-ku, Tokyo; President: Futoshi Fukuzaki), from September 20.

"NightVeilTM" is a food with function claims that contains an active form of coenzyme Q10 to address both "skin" and "sleep". The active form of coenzyme Q10*2 has already been recognized for its function in "assisting to improve quality of sleep*3," and our research has newly reported that it also assists to "maintain skin moisture*4". This product features a refreshing citrus flavor of grapefruit, orange, lemon juices and the gentle sweet flavor of honey. It is designed to accompany those who are concerned about "dry skin" and "poor sleep quality".
